D.101 MINUTES – APRIL 2013 WORSHIPING COMMUNITIES COMMITTEE

The Worshiping Communities Committee **VOTED** to approve the Worshiping Communities Committee Minutes of April 11, 2013.

D.210 MISSION DEVELOPMENT RESOURCES COMMITTEE

D.100 AGENDA

The committee heard a report from Marilyn Gamm, Liaison to the Mission Development Resources Committee. Highlights included:

- 2013 Walton Award Grants.
- New Worshiping Communities Health Insurance.
- New Worshiping Communities Seed and Investment Grant Program awarded approximately \$360,000 grants and approximately \$240,000 remaining.
- New Church Grant Team awards with the goal of growing viable and sustainable new congregations. As of today eight grants of various amounts have been disbursed.
- Seven one time Presbytery grants for Congregational Transformation up to \$50,000 to support mid-councils' efforts to develop a process for helping congregations to begin a transformational way of life.
- Considering applications to refinance the mid-council's church loans was a major business item in 2013. The Synod of Mid-America has decided to get out of the church loan business.

D.200 1001 WORSHIPING COMMUNITIES

D.201 MID-YEAR 1001 "SEED" GRANT PROGRAM Philip Lotspeich, Coordinator for Church Growth, reported on the Progress of 1001 New Worshiping Communities The committee was informed of the websites: www.pcusa.org/1001 and/or www.onethousandone.org. A listing of 1001 Strategies for 2013-2023 was provided and each committee member received a copy of the new resource packet cards "Recipes for New Worshiping Communities." The Mid-Year 1001 New Worshiping Communities "Seed" Grant Program report was reviewed. To date it has disbursed \$262,500 in grants. Six months after receipt of a Seed Grant, a one-time Investment Grant of up to \$17,500 is possible. Approval is conditioned on real progress having been made toward meeting the definition of a new worshiping community.

D.202 NEW BEGINNINGS

The committee heard an update on New Beginnings from Philip Lotspeich. New Beginnings is an assessment-based discernment process for congregations who wish to make a decision about the direction of their ministry. Originally, the program was designed for use by churches struggling with issues of viability and sustainability. It has also proven helpful to those that, while still viable, are in a pattern that leads to decline. The process is designed to take five to eight months from start to finish, though many of the churches are taking longer. It happens in Four phases: assessment, leader training, discernment (thru small groups) and decision-making.

GENERATIVE DISCUSSION

The committee engaged in generative discussion around the topics Millennials and Discipleship. Articles "A Generation With Unrealistic Expectations" and Change Wisely, Dude were used as the foundation for this segment. (Attachment 1)

- All generations benefit from this kind of conversation
- How to let go of leadership and not lose the church
- Benefits of internal generational communications

D.209 GHOST RANCH 2013

Debra Hepler, Director, Ghost Ranch Education and Retreat Center, gave a presentation which included the 2013 Strategic Plan Outline and Five-Year Plan Goals:

Partial Strategic Plan:

- To set a clear plan and direction for Ghost Ranch
- To be aligned with the Presbyterian Church (U.S.A.) mission directives
- To be financially sustainable to enable the continuing mission of the Ranch.

Partial list of Five Year Plan Goals:

- To increase Presbyterian Church participation,
- Have a Successful Capital Campaign.
- Sale of Santa Fe building,
- Get an Agreement with Water Authority on water storage in Abiquiu Lake.

COLLEGIATE MINISTRIES UPDATE

NEW WORSHIPING

The Committee heard from Sterling Morse, Coordinator, Cross Cultural Ministries, on the Racial Ethnic & New Immigrant Church Growth Consultation held May 22-23, 2013, and the African American Church Growth Strategy Consultation held May 23-25, 2013, both held in Louisville, Kentucky.

Rhashell Hunter, Director, Racial Ethnic & Women's Ministries/PW introduced Sun Bai Kim, Associate for Korean Emerging Ministries who gave an overview on the work of this office and shared highlights from the National Council of Korean Presbyterian Churches – 42nd Annual Conference. They currently have 400 Korean congregations and 50,000 active members spread over 15 synods and 120 presbyteries.

The Committee heard an update from Charles Wiley, Coordinator, Theology Worship and Education, on the Presbyterian Church (U.S.A.) Directory of Worship. The Directory of Worship is, in essence, the liturgical theology of our denomination. The 216th General Assembly (2004) Referral Item 04-12 directed the Office of Theology and Worship to prepare a revision. This process was delayed while the new Form of Government was developed. The revision is to be presented to the 221st General Assembly (2014) in Detroit.

Charles Wiley updated the committee on the Interfaith Consultation held September 19-21, 2013, in Stony Point, New York. The General Assembly Committee on Ecumenical and Interreligious Relations (GACEIR) hosted an Interfaith Consultation in order to produce an Interreligious Stance, a guiding document for the Presbyterian Church (U.S.A.) similar to the Ecumenical Stance that was approved by the 218th General Assembly (2008). GACEIR has worked to ensure that participants reflect a diverse cross-section of our church. A writing team appointed by GACEIR worked together during and after the consultation to draft the document. The Interreligious Stance document is to be presented to the 221st General Assembly (2014) in Detroit.

Clare Lewis, Publisher for Congregational Ministries (CMP) in Theology Worship and Education, reported to the committee on the new denominational curriculum Engage "Discipleship" is available. She stated publishing has started working on the next Engage curriculum "Mission." Publishing continues to work collaborative with Collegiate Ministries to provide worshiping resources for young adults, and with Evangelism and Church Growth to produce an Engage curriculum for young adults.

Ray Jones, Coordinator for Evangelism introduced David Loleng, who is the acting Interim Associate for Collegiate Ministries. David Loleng, Associate for Evangelism will continue the work for Collegiate Ministries and UKirk.

The committee viewed a video of the New Creation Church in Nashville.
