Subject: 2015 and 2016 Adjusted Presbyterian Mission Agency (PMA) Budget

#### **Recommendation:**

That the Finance Committee approve and recommend to the Presbyterian Mission Agency Board (PMAB) the 2015 Revised Mission Budget of \$76,611,903 and the 2016 Revised Mission Budget of \$78,027,204.

Additional amounts of \$989,592 for 2015 and \$811,991 for 2016 are needed from the Presbyterian Mission Program Fund (PMPF).

#### **Background:**

The 2015 and 2016 Mission Budgets were submitted to the PMAB for approval at the September 2014 meeting. These revised budgets are based on the following adjustments:

- 1. The total 2015 Revised Budget is \$76,611,903, which is a net increase of \$1,190,929 over the approved budget.
- 2. The total 2016 Revised Budget is \$78,027,204, which is a net decrease of \$1,814,840 over the approved budget.

#### **Adjustments**

The following tables present a summary of the adjustments included in the 2015 and 2016 revised operating budget projections for PMA expenditures (before cost allocation).

Adjusted estimates for the proposed 2015 and 2016 revised budgets are based on the following key assumptions:

- 1. Funds Development Fund-raising expenses were reduced to match revenue projections for Special Offerings and World Mission in both 2015 and 2016.
- 2. Mission The key components impacting this area in 2015 and 2016 are as follows:
  - a. CPJ An increase in expenditures related to Disaster efforts.
  - b. ECG A decrease in expenditures due to Program realignments and reduced Youth Triennium costs in 2016.
  - c. WM A decrease in expenditures related to the prioritization of Mission Coworkers and Regions.
- 3. Shared Services 2016 includes Information Technology costs increase due to the Office of General Assembly outsourcing of programming and development.
- 4. Other 2015 includes an increase for legal fee expenditures, offset by a decrease in Christmas Joy Offerings that are given to the Board of Pensions.
